

# About the Gerri C. Roberts Volunteer Awards

Gerri C. Roberts was a Tallahassee REALTOR<sup>®</sup> known for her dedication and service to the Tallahassee Board of REALTORS<sup>®</sup> and our community. We are proud to honor her memory and celebrate our members through two awards:

- Volunteer of the Year. This award recognizes a REALTOR<sup>®</sup> or Affiliate member for their volunteer service to the Tallahassee Board of REALTORS<sup>®</sup>. (Application, page 3.)
- Good Neighbor. This award recognizes a REALTOR<sup>®</sup> member for community volunteerism. TBR will contribute a grant award to a 501(c)3 charity designated by the winner. (Application, pages 4 and 5).





# <u>RULES</u>

The Gerri C. Roberts Volunteer Awards are part of the annual awards program, which includes REALTOR<sup>®</sup>, Rookie REALTOR<sup>®</sup>, and Affiliate of the Year awards. Please note the following:

- Members may apply for only one annual award: REALTOR<sup>®</sup> of the Year, Rookie REALTOR<sup>®</sup> of the Year, Affiliate of the Year, Volunteer of the Year, or Good Neighbor.
- For each annual award category (REALTOR<sup>®</sup> of the Year, Rookie REALTOR<sup>®</sup> of the Year, Affiliate of the Year, Volunteer of the Year, and Good Neighbor), members are limited to winning once every five years.

## Volunteer of the Year Nominee:

- Must be a REALTOR<sup>®</sup> or Affiliate member in good standing.
- Must complete and submit the Honor Society Application, meeting the minimum points required for eligibility.
- Must complete and submit page 3 of this application.
- Should have volunteered for or on behalf of the Tallahassee Board of REALTORS<sup>®</sup>.

### **Good Neighbor Nominee:**

- Must be a REALTOR<sup>®</sup> member in good standing.
- Must complete and submit pages 4 and 5 this application. (There is no additional requirement to complete the Honor Society Application.)
- Should have contributed to a program that improves the livability of a community; those activities are not limited to real estate or housing issues.
- Should have made a significant contribution of personal time, but contributions of money, materials, or other resources will also be considered.
- Should have completed some portion of their community work during the award year; however, ongoing efforts outside that time frame that demonstrate a depth of commitment will be considered.
- Should be able to document the results of their individual involvement through published reports and/or testimonials from the organization they served or the people they helped.
- Grant awards will only be issued to a 501(c)3 nonprofit organization.

# JUDGING CRITERIA

Applications will be judged by at least five members who are past presidents or current members of the Member Resources Committee. The total points awarded by all judges will be tallied to determine the winner in each category.

- Depth of contribution (time, vision)
- Impact of the contribution (results)
- Leadership/initiative
- Role model for other REALTORS®

#### **Good Neighbor**

- Depth of contribution (time, vision)
- Impact of the contribution (results)

- Leadership/initiative
- Role model for other REALTORS®
